



DEMOLITION GENERAL NOTES:

1. FIELD VERIFY ALL DIMENSIONS PRIOR TO BEGINNING DEMOLITION.
2. ALL DIMENSIONS ARE TO FACE OF SLAB, FINISH FACE OF WALL, ϕ OR EDGE OF STRUCTURAL MEMBER, OR ϕ OF OBJECT; U.N.O.
3. FIELD VERIFY EXISTING LOCATION OF ALL UTILITIES PRIOR TO ANY SAW CUTTING OF EXISTING PAVING FOR TIE-INS.
4. REPAIR ANY DAMAGE TO EXIST. SITE CONDITIONS DUE TO CONSTRUCTION.
5. STAGING OF ALL NEW MATERIAL SHALL BE WELL MANAGED IN ORDER NOT TO DISRUPT THE SITE, SITE ACCESS, AND OVERALL APPEARANCE TO THE SURROUNDING AREAS.
6. EXISTING SITE PLAN HAS BEEN PERMITTED SEPARATELY AND SUBMITTED FOR TAS REVIEW UNDER SEPARATE PERMIT.

- 01 REMOVE EXISTING WHEEL STOP
- 02 REMOVE EXISTING PARKING PAINT STRIPE AND PREPARE AREA FOR NEW COVERED OUTDOOR DINING CONSTRUCTION
- 03 REMOVE EXISTING STOREFRONT TO BOTTOM OF INTERMEDIATE STRUCTURE AND PREPARE OPENING FOR NEW WALL AND STOREFRONT INSTALLATION
- 04 REMOVE EXISTING STOREFRONT DOOR AND REUSE AS EMERGENCY EXIT DOOR IN NEW STOREFRONT INSTALLATION
- 05 DEMO EXISTING EXTERIOR CMU WALL TO POINT INDICATED AND PREPARE OPENING FOR NEW WINDOW AND/OR DOOR INSTALLATION
- 06 REMOVE EXISTING METAL DOOR AND REUSE IF POSSIBLE IN NEW LOCATION AS ILLUSTRATED IN NEW FLOOR PLAN
- 07 CLEAN, PATCH, REPAIR, AND LEVEL EXISTING SLAB AS REQUIRED IN PREPARATION FOR NEW FLOOR FINISH APPLICATIONS
- 08 DEMO EXISTING METAL DOOR AND FRAME AND PREPARE OPENING FOR NEW METAL STUD INFILL
